




# South Carolina: Lowest Operating Costs in the Region

# Busiest Port Along the SE & Gulf Coasts




- Ranked 9<sup>th</sup> in the United States based on container volume; 82<sup>nd</sup> worldwide.



## May 2018




Total Active Projects = 342

May 2018


